In course of Global expansion of Hinemos subscription, US Atomitech (100% share owned by Atomitech Inc.) will start its digital distribution sales of Hinemos subscription for customers in US. Along with its sales in US, English support for products and/or English documents are available at the same time.

INTELLILINK and Atomitech will strengthen cooperation with other Hinemos Alliance enterprises*¹ and target to achieve annual 500ea sales of Hinemos subscription.

Hinemos Subscription will be distributed from an online store "Hinemos Store" maintained by US Atomitech.

Product support in English, which are to start at the same time, will be included in Hinemos Subscription distributed from "Hinemos Store".
